

The meeting was turned over to the new officers with Bob presiding. The Board expressed their thanks to Gene for a very successful year.

The Board voted to continue Ham Holiday in 1978 following a poll of the Clubs to determine interest. A Site Selection Committee was formed with Carl, W5JJ, serving as chairman. Other members include Frank, N5FM; Ken, K5UAB; Joe, WA5ZNF; George, W5NTL. A tentative check list of items to be considered in site selection included adequate space for the flea market, dealer displays, parking, and a dining area for 700 or more. Meeting rooms for technical programs and ladies hospitality are also important. Close by parking for campers and motor homes would be desirable. The Committee is to report to the Board at the October meeting.

The date for Ham Holiday 1978 is to be somewhat flexible until site selection is made. The organization of the standing committees was discussed and the Board assigned each committee function to a club. Chairmen for each committee will be named by October. Club assignments were:

# GREETINGS TO THE OKC/CORA GANG:

Well here I sit with six weeks done and 46 left to go. Judy dropped a letter regarding Ham Holiday IV with all of the short notes so many of you took time to write. I really appreciated and enjoyed them. HH IV was apparently quite successful. Judy said the micro computer/ processor sessions were Standing Room Only. I was glad to see that this year the major prize was an HF rig. That in itself indicates that HH is a "hamfest" as opposed to an FM-oriented doings. It needs to be kept that way in my opinion. I can visualize continued growth for HH in the future. Always remember that the Dayton Hamvention started in 1952 with about 250 registered the first time. If everything were as successful this year as it seems to have been, registrations might go to 1000 or more next year. I definitely will be there in '78. Assuming I get a license up here, you can put me down on next years program for "Hamming In The Land Of The Midnight Sun" . Speaking of hamming up here, I'll try to bring all of you up to date on the situation. Prior to about 1970, The Government of Iceland (GOI) granted licenses to U.S.hams. About that time the GOI extended the "12 mile limit" out to 200 miles for fishing, just as the U.S. did recently. The British did not take too kindly to that and came inside the new 200 mile limit with Royal Navy destroyers, etc. to back them up, thus opening what were known as the "Cod Wars". The U.S., since it is allied with both Iceland and Great Britain was in a virtual "between a rock and a hard place" situation. The U.S. position at the time displeased the GOI considerably. About the same time, a TF ham who was a ham in the GOI went to the U.S. and tried to get FCC operational okay there. He was told he couldn't because of no reciprical treaty. For better or worse, the system here is of a socialistic nature. The Vietnam war was quite a big affair at the time also. most of you recall, the U.S. did not enjoy any great swell of popularity among socialist nations at that time. In any event, as an apparent result of these and other factors, the TF licenses of U.S. hams were revoked. Since that time the GOI has moved back a bit toward being pro-West, thus changing the climate a bit. Also IRA (equivalent to ARRL) elected a new president who is in favor of reciprical agreement. Negotiations between the Foreign Minority and the US State Department were started last fall. Enter the evil villain from stage left. Icelandic amateur regulations provided for licensing if non-citizens but required residency of 6 weeks before granting a license. Since none of the other 48 reciprical treaties the US has has entered into had any such condition the US halted the negotiations so as not to set a precedent. That is where things have been until May or June. The amateur radio rules here have been re-written to eliminate the 6 week residency requirement. They have been "offifially" translated to English now. As soon as the official English rules are printed the negotiations will be re-opened. I have hpes that all will be well in two or three months. There is one other possibility. A friend from my days in Germany is married to a YL Icelander ham and has good contact with some of the TF hams. He has made a formal request that foreigners be allowed to take the Icelandic amateur exams. We hope that will go through more quickly. We would also get a TF call rather than operate /TF. Keep your fingers crossed.

There is a 2 meter repeater going up in the near future also. I expect it will be out of range for me here since it will be about 200 miles away. I'll keep everyone posted on the progress. The States comes through weakly around 1200% to 1400% and also 1700% to 1900% on 20. I am using (SWL) a KWM-2 and dipoles (not ham band) at 70 feet. I found a brand new TA-33 in a box in the MARS station two weeks ago. Tower is already up but rotator is shot. There is also an old Ham-M (I think)

without a control head. Unless I can conjure up some means to rotate it, the beam will have to be fixed in one direction only. It looks like Judy may really get after it and get a license to operate HER newXCVR. She made no bones about letting me know whose rig it is, HI! I've got to try to keep from nagging her about it too much, though. Another motivation for her is that the GOI will not allow MARS to make phone patches or even send messages by voice. She will have to get a license to talk to me. Telephone calls are \$5 per minute. Well, now everybody knows that even without a rig and/or repeatOr, I can still be long-winded. Hope to be able to QSO with you all soon.

A MINORITY VIEW: "CODDLING HAMS"

CODDLING - - To treat with extreme caution or sensitivity; to "handle with kid gloves." -- Webster

By the time you read this, one of Oklahoma City area's newer amateur radio stores will have closed its doors. In a state where we often hear talk about the scarcity if ham outlets, the closing is of interest.

In an informal conversation recently, the owner of the store spoke candidly of a number of reasons for the closing of his new business. One of his comments struck me as particularly significant.

He said he had been naive in his plans for the ham trade. He said most amateur radio operators qho visited his establishment expected a bigger discount from the list price than he got as a markup from the manufacturer. It was not unusual, he said, for a ham to demand a 15% discount on an item on which the dealer's margin was only 10-12%.

What happened when the dealer refused the traditional "ham disc-ount?" The prospective customer, more often than not, walked out. Rseult: The store closed.

As a relative newcomer to the amateur ranks, I have been mystified by the general attitude that hams can blandly ask for a discount. True part of the fun in the hobby can be looking for bargains and in seeing how much can be obtained for how little investment. But many hams seem to think a discount is their right, and it's this attitude that I think is wrong and harmful to the amateur radio business side in Okla.

Sure, there are places more densly populated which do so much business that they can buy in quantity, get gear somewhat cheaper, and can therefore offer discounts. And I agree with my friend Carl, WB5QNK who can get downright rhapsodic about how much better and more helpful some of the big stores in the east can be. My point though, is that our part of the country does not have the population density to support those big operations; I sincerely believe that we hart the local ham stores -- and in the long run diminish their quality (and hence our fun) by always pressing for discounts when these may not be possible with the local volume.

Personally, I've tried to buy from local outlets, and I've never asked for a discount. The system -- which most of us are so eager to defend -- builds in the dealer's margin of profit by setting a suggested retail price. When you go in and seek a discount, it may make you feel clever; in my view, it's an attempt to subvert the system.

What should you ask for from a local dealer in exchange for your business at suggested retail price? I think you should demand:

- 1. Full information abou the product, its claims, method of operation, and so on.
- 2. Prompt delivery in mint condition.
- 3. Help -- via telephone or by in-store contact -- if you have trouble making the gidget work.
- 4. Quick and expert service locally under warranty, w/o charge.
- Quick and expert service locally, for a fee, after the warranty period.

6. A fair trade-in if you decide later to go back and upgrade to some better piece of gear.

Most of these services cannot be had from a mail-order discount house. As 73 magazine pointed out in its September issue, many of the big mail discounters put each other out of business, and your dealer may not even be there if you try to go back.

Of course I know that there are items we all have to buy from mail houses because they aren't available to us by any other means. And no one in his right mind would turn down a chance to buy a great piece of gear for a small price on a trip to Japan, say, or even Ohio. What I'm arguing against is the long-term assumption that we as hams have a discount coming always, AS A RIGHT.

We don't in my opinion, and as long as most of us expect local dealers to coddle us in this way, we, re going to have stores with low inventory, missing product lines, and sales staffs that are not always on the ball.

Because as long as we think it's our God-given right to get things cheaper than the average bear, that's what we're going to get, you see: cheap service. When hams are willing to pay the suggested retail price they may pave the way for the kind of retail operations locally that they say they want.

### I DON'T WANT A PICKLE,

I just wanna ride on my motorsickle. The opening lines of a currently popular song by Arlo Guthrie are just about as silly as one has to be to pull off a stunt like I just finished. I always wanted to do some touring of New England so when an opportunity to make a company sponsored visit to Springfield, MA came up, I packed up my motorsickle and headed Northeast.

If this was a motorcycle publication, I would elaborate on the motoring, but it is not, so let me say briefly that I rode 1700 miles to Springfield, 1300 miles around New England and 2000 miles back (through Smokey Mountains). I arrived home is pretty good shape except fatigued from a bad cold I caught before I left Springfield.

Here is the radio part of the story. The first free evening I had, I went to Newington, Connecticut to, you guessed it!, ARRL Headquarters. The HQ office was closed but W1AW was open. I have misplaced the name and call of the gentleman who was operating the station but he was very accommodating and friendly, giving me a very detailed tour of the station, even down in the basement, where the most amazing collection of QSL cards I could ever imagine were kept. (Chris, W1EH, ed.)

When I arrived, he was taping bulletins to be aired later. W1AW was not operating so he asked if I would like to operate. I told him not really, unless the 75 meter band happened to be open into the Midwest (weather net time). He retuned the final amplifier and remote antenna tuner to 3900 kHz and seated me at one of the visiting operator's positions equipped with a TS-820. The band was not open so as it turned out, the only operating I did was to key the transmitter while he tuned the final. After I finished with my frivolity, he retuned to 80 meters for code practice.

Code practice is sent by using a five level (Baudot) teletype tape prepared by

using a keyboard/video/punch machine. The tape is fed to a reader which converts the Baudot code to telegraph code with insertion of proper letter, word and sentence spacing. A single master oscillator is hetrodyned to the operating frequencies and a bank of amplifiers simultaneously transmit on all bands. On HF, the station transmits code using 160 & 80 meter doublets, 40 meter yagi and a pair of phased 20 meter yagis. A rhombic which has been tried on 40 meters was unsatisfactory because it was too directional! It covers Southern California well but misses the Pacific Northwest. The yagi has been much more satisfactory.

The station is equipped with emergency generator and many back-up systems to allow it to have a high degree of reliability. The equipment installation is neat with cabling and wiring running in raceways in the floor joists, accessible in the basement. Most coax feedlines are run underground to the towers.

I looked at some of the hardware from past projects such as Oscar antennas and equipment and the operator fired up a rotary spark gap equipped with a code wheel to send "CQCQ W1AW." It was the first time I ever saw a rotary spark gap in operation and I must say that now I understand why the big ones were described as "im-pressive."

My operating was confined to two meters, FM while I was on the trip. On a motor-cycle one doesn't do too much radio operating while on the move. At rest stops, I would whip out the Handie Talkie (R) and see who I could contact. I was never out of range of a repeater whenever I tried it. I made some nice acquaintances around the Hartford/Springfield area, getting a couple of invitations to visit. With all the sightseeing, I thought I might run into an amateur somewhere but I never did.

In conclusion, I will answer the question that many have asked, "Would you do it again?" My answer is well, not quite the same way. Nothing is more boring than interstate highways on a motorcycle. Whenever possible, I would like to allow more time, take the secondary roads and further investigate some of the scenery, people and places off of the concrete rat race.

### ANOTHER REAL PICKLE



### NEW REPEATER REGULATIONS

The following came off the teletype and was submitted by Joe, WA5FLT: NEWINGTON CT SEPTEMBER 22, 1977
TO ALL RADIO AMATEURS BT

ON SEPTEMBER 21, 1977, THE FCC ACTED ON DOCKET 21033, REPEATER RULE SIMPLICATION. EFFECTIVE IMMEDIATELY NO NEW APPLICATIONS FOR NEW REPEATER, AUXILIARY LINK, AND CONTROL STATION LICENSES WILL BE ACCEPTED. THE FOLLOWING ARE ALSO EFFECTIVE NOVEM-BER 4, 1977. DISTINCT LICENSES FOR REPEATERS, AUXILIARY LINK, AND CONTROL STATIONS WILL BE ELIMINATED. THESE MODES OF OPERATION WILL BECOME PRIVILEGES INHERENT IN ALL INDIVIDUAL PRIMARY LICENSES AND CLUB STATION LICENSES. THIS MEANS THAT DISTINCTIVE WR PREFIXES FOR REPEATERS ARE BEING ABOLISHED. HOWEVER, PRESENT REPEATER, AUX-ILIARY LINK, AND CONTROL STATION LICENSES REMAIN IN EFFECT TILL EXPIRATION, AT WHICH TIME THEY WILL NOT BE RENEWABLE. ALSO, APPLICATIONS FOR REPEATER STATION LICENSES NOW ON FILE WILL BE DISMISSED WITHOUT ACTION. PORTABLE AND MOBILE OPERA-TION OF AUXILIARY LINK STATIONS HAS BEEN APPROVED. IN ADDITION TO THE PRESENT RE-PEATER SUBBANDS THE FOLLOWING FREQUENCIES HAVE BEEN MADE AVAILABLE FOR REPEATER USE. 144.5-145.5 MHZ, 220 MHZ AND UP, EXCEPT FOR 435-438 MHZ. TECHNICIAN CLASS LICENSES HAVE BEEN GRANTED ADDITIONAL PRIVILEGES AT 144.5-145 MHZ SO THAT THEY MAY USE THE NEWLY CREATED REPEATER SUBBAND ON TWO METERS. THIS GIVES TECHNICIANS PRI-VILEGES ON 144.5-148 MHZ IN ALL ON TWO METERS. THE IDENTIFICATION INTERVAL FOR REPEATERS HAS BEEN EXTENDED TO AT LEAST ONCE EACH 10 MINUTES. STATIONS OPERATING October 1977 CORA Collector & Emitter 15

IN THE REPEATER MODE SHALL IDENTIFY EITHER BY PHONE BY ADDING THE WORD REPEATER AFTER THE PRIMARY CALL SIGN, OR BY CW BY FOLLOWING THE PRIMARY CALL WITH /RPT. STATIONS OPERATING IN THE AUXILIARY LINK MODE (OR CONTROL MODE - THE CONTROL FUNCTION HAS BEEN COMBINED WITH THAT OF AUXILIARY LINK) SHALL IDENTIFY EITHER BY PHONE BY APPENDING THE WORD AUXILIARY AFTER THE PRIMARY CALL, OR BY CW BY INCLUDING /AUX AFTER THE PRIMARY CALL. TRANSMISSIONS FROM OPEN ACCESS AUTOMATICALLY CONTROLLED REPEATERS NEED NO LONGER BE MONITORED OF RECORDED. THERE WAS NO ACTION TAKEN ON THE ESTABLISHMENT OF PRIORITIES FOR FREQUENCY USE, ON MODIFICATIONS OF THE PRESENT EFFECTIVE RADIATED POWER VERSUS HEIGHT ABOVE AVERAGE TERRAIN REQUIREMENTS, OR ON THE ELIMINATION OF THE REQUIREMENT THAT A RECORD OF THIRD PARTY TRAFFIC MUST BE MAINTAINED IN THE LOG OF A REPEATER STATION, OR OF A STATION OPERATING IN THE REPEATER MODE. AR





QST. Sep, as usual, presents a number of good articles. Perhaps the one on an 80-m vertical antenna is best, with one on a Maritime Mobile trip around S. America the most pleasurable reading.

IEEE SPECTRUM, Aug, has an update on power semiconductors.

IEEE VTG NEWSLETTER, Aug, courtesy of W5KE, centers on mobile operation, with a wealth of information.

HAM RADIO, Sep, gets deeply into pi-network design; it is very good, even daring to admit that most feedlines present a complex load, not the resistive one presummed by other authors! Double-balanced mixers get a tumble, and there is a method of modifying a frequency counter to serve also as a frequency synthesizer. An overly-complex method of designing low-voltage regulated power supplies is given.

73, Sep, devotes most of its pages to RTTY. It does tell how to build a 2-m synthesizer and passes a few tips on mobile antennas.

ELECTRONIC PRODUCTS, Aug, presents the case for switching-type voltage regulators.

ELECTRONICS RETAILING, Aug, calls for support of the "Goldwater Bill", a pleasant change from the attitude of audio radio, and TV manufact-urers who oppose spending a few cents to shield or filter their products!

#### CODE SENDING TEST NO LONGER REQUIRED

In a Public Notice dated 22 August 1977 the FCC announced that a test in sending International Morse Code no longer will be administered by the FCC to applicants for Amateur Radio Operator licenses. The reason: Practically no person who passed the receiving test ever flunked the sending test; therefore, why give it? Good reasoning!!!

The same notice stated there had been a five-fold increase in amateur examinations during the past three years.

Novices and applicants for commercial radio operator licenses still will be required to pass both receiving and sending tests.





#### USING PIN 5 ON THE 555

When using the NE 555 or RS 555 (or any other name for that super versatile timing chip) the control voltage pin (#5 in the 8 pin dual in-line package) is almost always bypassed to ground and that is the end of it. But by using this pin the chip becomes even more versatile. Just by adding a few parts to the plain astable circuit the 555 can become a F. M. signal source, or with a sawtooth generator, it can become a sweep generator. Pin 5 can be used to control the length of the delay in the monostable mode also.



What Pin 5 Does Internally. Pin 5 is labeled the control voltage and justly so. The voltage on this pin determines the voltage at which the threshold comparator will reset the chip. Normally the voltage is roughly 2/3 of the Vcc voltage. Just by putting a higher voltage on pin 5 the length of time the output stays high in the monostable mode can be increased. Conversely, lowering the voltage on this pin shortens the time. This can be done by adding a single pot. Of course the same result can be achieved by varying the resistance of the timing resistor R 1. But you don't have to worry about turning the resistance down too low on the pin 5 voltage like you do on R 1 (pin 7 discharge current can become too high and overheat or destroy the chip). Also higher frequency capability may be achieved by using the control pin, because some poor quality capacitors have high leakage rates and will not charge up to 2/3 Vcc. If you put a combination of R 1 and C 1 on the chip in the astable mode to get a certain frequency output you can always just lower the reference voltage on pin 5 and make the output frequency higher, at least until you reach the limit of switching speeds of the internal flip flop. I have had a 555 up to 2 MHz by varying the voltage on 5.

If you are familiar with how the 555 works you've probably followed this, but if not, you're probably lost. I'll try to explain how the 555 control pin determines the time delay.

The timing portion of the chip is usually made up of a resistor and capacitor. In the monostable mode, the chip can hold the voltage on the capacitor at near zero by an internal transistor. (See Fig. 1) When the chip is triggered by a negative going pulse whose voltage is below 1/3 Vcc the output (pin 3) goes high. The capacitor which was held at zero volts by the internal transistor is allowed to start charging. The speed at which the capacitor charges is determined by the size of R 1 and C 1. The voltage increases until it reaches 2/3

Vcc then the threshold comparator causes the chip's internal flip flops to reset. When reset, the capacitor is held discharged by the internal transistor and the output goes to zero and the chip will remain in this state until it receives another negative pulse at pin 2. What we are concerned with is the timing portion R 1, C 1 and the threshold comparator. If R 1 and C 1 are fixed, the charging rate is fixed. The length of time it takes the capacitor to go from zero to 2/3 Vcc is constant. But if the comparitor is adjustable (and it is) the time can be varied. Instead of having to go to 2/3 Vcc, the voltage can be adjusted anywhere from 0 to Vcc. The lower the referince voltage on the comparator, the faster the time.

In the astable mode the timing portion is made up of R 1, R 2 and C 1 (Fig. 2). The main difference is the addition of the other resistor R 2. The chip just cycles between a charging and discharging of the capacitor. The output of the chip is high when the 555 is charging the capacitor and low when it is being discharged. The length of time the output is high is determined by R 1 and R 2 as it charges through both. The output low time or discharge time is determined by R 2 only as pin 7 goes to ground and the capacitor discharges through R2 only. The astable mode is commonly used for audio oscillators, etc. Again by leaving R 1 and R 2 fixed we can vary the frequency of oscillation by the control voltage. Again, the lower the voltage on pin 5 the higher the frequency and vica versa.

If an audio voltage is fed into pin 5, a frequency modulated signal will result. I used a 555 to generate a 455 kHz signal and was FM'd and fed into the I. F. of an old receiver. Perfect! The audio was good and just by controlling the peak-to-peak voltage the deviation was adjustable. If the 555 was set so it generated an audible tone and a sawtooth generator was used to provide the control voltage a sweep generator would be made! Another 555 with an emitter follower could be used to generate this voltage.

I'm sure there are many uses of the 555 not yet discovered or not well known such as the pin 5 voltage control and just as many more uses of this great chip. BUT we'll never know until you start playing around with this two-for-a-dollar chip.

#### METRIC, ANYONE ?

National Geographic Magazine for August, 1977 has an interesting article about the conversion to metric. We have summarized this article using some quotations.

"Each day in the United States an estimated 20 billion measurements are made. The scientist, for his measuring, uses the metric system--logical, simple, and unified. But for most of us, what an antiquated, crazy-quilt hodgepodge we customarily employ!" Three different sized quarts are listed, there are five sizes of the ounce and six different tons. When barrels of oil are numerated in energy crisis reports, is each barrel 31 gallons, 42 gallons, or somewhere between?

Quickly, now. If there are 80 chains in a mile, which mile do we mean: survey mile, international mile or nautical mile. The survey mile is roughly one-eighth of an inch longer than the international mile, but both are called statute miles. So, how long is that chain?

"We divide the gallon into four quarts, eight pints or 16 gills - to say nothing of five fifths. We split the mile into eight furlongs, 80 chains, 320 rods, 880 fathoms, 1,760 yards, and 5,280 feet. Then we divide the foot by 12 to get inches - - - all part of a gloriously illogical mingle-mangle of some 80 separate measures."

"How we got into this muddle is a story that goes back to the Babylonians and Egyptians, to the Romans and Vikings, and to assorted English monarchs of centuries ago."

The mile was 1,000 double steps by a Roman legionary. Queen Bess wanted the mile to relate to the furrow, so she added 280 feet to make the mile equal to eight furlongs. "Henry I established the yard as the distance from the tip of his royal nose to his fingertips." The inch was the span of the knuckles on King Edgar's thumb and the foot was the length of Charlemagne's own foot.

"Revolution and the upsurge of interest in science produced a system based on 10's -- the metric system. It was the most remarkable plan for measurement ever devised. Its keystone was the meter, from the Greek METRON, meaning 'a measure'. - - - The metre, as approved by the French National Convention in 1795, was to be one ten-millionth of the length of earth's meridian between the Equator and the North Pole." A liter was established by cubing a tenth of a meter. "And a liter of water produced a basic unit of mass, the kilogram. - - - the meter has been redefined - - - as 1,650,763.73 wavelengths of orange-red light emitted by the krypton-86 atom. - - - The pound, the foot, and other customary units were redefined as fractions of the metric units. - - on December 23, 1975, President Gerald R. Ford signed the Metric Conversion Act of 1975, calling for voluntary conversion to the metric system and establishing a U.S. Metric Board to coordinate that conversion." The conversion is well under way. "Of the top 1,000 major manufacturing and industrial concerns in the United States, more than 60 percent are estimated to be metric or in transition." The conversion is considered to be not too big a problem. The younger generation is being taught metric in school, but those of us who grew up with customary units will be provided products having both metric and customary measurements.

" - - - the advice of other countries now successfully making the transition is to avoid translating as much as possible. 'Learn to think metric from the beginning,' they counsel. 'Then the change-over goes smoothly'."

After all the hassle about metric vs customary measurements they are now arguing about whether to spell it "meter" or "metre"!


PROPAGATION SEPTEMBER 26 - OCTOBER 10. The solar fever has increased and activity on the sun has now surpassed the levels expected or even hoped for, in recent weeks. Several new active regions have given off potent Class-X flares along with lesser bursts of energy. 2800-MHz solar flux numbers continue well over the 100 level indicating excellent band conditions with high MUFs.

Harvesting This Solar Bumper Crop, comments Oak, may require our putting up with periods of disturbed conditions such as the one in progress at press time (September 19-22). However, the fine conditions on better days will amply compensate.

Present Activity Levels, coupled with approaching known active solar regions, should continue to enhance propagation through the end of the month and then resume about October 4, barring a further solar surprise. Continuing flare activity will require day-to-day observation to catch peak conditions. 21-MHz European and Asian openings will become a daily event while the period of high activity persists, and even 10 meters won't be dull. Lower bands will also be productive during the period.















#### HOW TO FIGURE OUT WHAT WWW IS FORECASTING, Etc

This chart from WB5BFZ may help lift the veil of mystery. Be a Believer!! There is a reason for most everything.....sometimes.


